

Diagrama Foundation is a charity that cares for the needs of vulnerable people who are experiencing social difficulties, at risk of exclusion or who are similarly disadvantaged, with the defence and promotion of human rights at our heart. Our main objective is to promote the development of centres, programmes and research aimed at the prevention, treatment and integration of people in social difficulties or at social risk, especially children, families, young people and dependants.

The foundation was established in the UK in 2007, under its full name "Diagrama Foundation Psychosocial Intervention" and in 2009, we obtained charity status in England and Wales.

We operate principally in non-secure environments and our services, on behalf of wide range of public and private sector clients, include children's homes, residential services for adults with special needs, fostering and adoption, therapeutic services, secure and non-secure transportation as well as education and training for children and adults.

Our background comes from our parent organisation, Fundación Diagrama (Spain, 1991), as well as from our sister organisations, Association Diagrama (France), Diagrama Foundation Inc. (USA) and Diagrama GmbH (Germany). All of these organisations make up Diagrama International (Belgium). Diagrama follows the same principles and values in every country where it develops its activity.

## RESTORATIVE JUSTICE FOR VICTIMS OF YOUTH CRIME

The project REVIJ- Reparation to the victim in the European Juvenile Justice Systems: Comparative analysis and transfer of best practices- aims to conduct a comparative of the measures provided for victims in the European Juvenile Justice Systems, focusing on analyzing two things. First, in relation to respect of rights, support and protection to victims of crime, if it is in compliance with Directive 2012/29/ EU of the European Parliament and of The Council, of 25 October 2012, establishing minimum standards on the rights, support and protection of victims of crime. Second, the practices that are carried out in restorative services in the juvenile justice field, and the type of guarantees they offer to victims.

## OBJECTIVES

- Obtaining a shared vision about restorative justice services for the victim in the field of juvenile justice.
- Analyzing the compliance with the Directive 2012/29/UE of the European Parliament and of the Council, regarding respect of rights, support and protection of victims.
- Compiling a compendium of best practices.
- Proposing guidelines that can be used by professionals and policy makers.
